## TWIN TOWERS GUTTER REPLACEMENT \$22,900.00

Replace old raised gutter cap and rebuild gutter trough to a flat horizontal surface with housings and grates against back wall of new gutter.

- 1) Remove gutter beam coping cap and haul away.
- 2) Cut front of gutter trough down 1" to 1.50" so it's lower than original height.
- 3) Extend gutter plumbing up approximately 4" and add new gutter housings and grates.
- 4) Fill in old gutter trough with cement to level of new gutter housing.
- 5) Install 1.25" thick x 16" long x 8" deep travertine on beam of pool w/1.5" overhang of gutter. Travertine will be flush with pavers on pool deck.

This quote is for design approval, if accepted, Engineering, Health Department approval, drawings, and permit fees are all to be determined.

3 feet of pavers will need to be removed, stored and then reinstalled by a paver company once gutters are complete. This is not part of our quote or contract.
